

# SEASONAL LOCKER LOTTERY

## *Victor Constant Ski Area*

### Standing Operating Procedure

1. GENERAL:

There are 140 seasonal lockers on the lower floor of the Class of '48 Ski Lodge available for rental annually for occupancy by eligible patrons. Seasonal lockers are capable of holding two (2) sets of skis, boots and poles, or four (4) pairs of skis. Occupants are selected first come, first served starting the day of the Ski Swap.

2. ELIGIBILITY:

Season locker occupants must be authorized IAW Army Regulation 215-1.

3. SEASON:

- a. Seasonal lockers may be occupied from **13 Nov 2011 thru 1 Apr 2012**.
- b. Victor Constant Ski Area closes in mid-March. Equipment and locks must be removed from seasonal locker by 1 Apr 2012. Access to Ski Lodge is not permitted after this date as Victor Constant Ski Area will be closed and inaccessible. Items left behind are assumed property of the Victor Constant Ski Area and may be disposed of as such.

4. LOTTERY:

- a. The Lottery has been discontinued.

5. SIGN-UP:

- a. Pre-season locker sign-ups will begin the day of the Ski Swap, November 13<sup>th</sup> for all Active Duty members. Sign-ups for All Others (including DoD Civilians) will begin November 14<sup>th</sup>.
- b. After the weekend of the 13<sup>th</sup>-14<sup>th</sup> there will be no opportunity for locker reservations until the Ticket Office re-opens December 12<sup>th</sup>.
- c. Those wishing to rent a seasonal ski locker must FIRST report to the locker room with proper identification to obtain a Locker Number Slip from the Locker Room Attendant.
- d. Locker Number Slip will be presented to Ticket Office cashiers for payment.
- e. Payment is required at time of reservation.
- f. If all lockers are claimed, a waiting list will be started.
- g. Lottery applications will be available at <http://www.westpointmwr.com/ACTIVITY/SKI/index.HTM>. Please have this application completed prior to requesting a locker.
- h. Only one (1) Locker application will be accepted from each household unless there are two members on Active Duty in the same household.

6. PAYMENT:

100% of the seasonal locker fee must be paid at the time of the locker request. **Failure to satisfy payment deadlines will result in forfeiture of reservation.**

7. POLICIES:

- a. Occupancy of a seasonal locker is by the approved eligible patron or immediate family only.
- b. Subletting or selling of seasonal locker privileges is prohibited.
- c. Penalty for violation of policies may result in cancellation of seasonal locker with no refund.
- d. Lockers must be emptied by 1 April, 2012
